Good Afternoon Clerks to Town & Parish Councils and Chairs of Parish Meetings

As we approach the Summer holidays and experience better weather, a reminder that we want to encourage responsible behaviour & respect in our parks, recreation grounds & public open spaces. This will help us monitor the situation and gather data to target resources and inform future Public Spaces Protection Order Council website <https://www.derbyshiredales.gov.uk/community/community-safety/public-space-protection-orders>

Our Clean & Green Team feedback on any issues they encounter and it is encouraging that we have had very little reported by them or anyone else this year.

However, we do receive odd reports about fires & BBQs and damage caused to the environment and street furniture through their use and potential risk of larger scale

Reports have also been received recently about incidents where dogs have been allowed to run freely in Bakewell Recreation Ground and Hall Leys Park Matlock. Dog (Bakewell Recreation Ground) between 11 am and 4 pm and may be off lead at other times, but must be supervised and all mess cleaned up and disposed of in a bin or taken home. Please

We urge residents also to not let their dogs roam freely & unsupervised around residential areas – we have had recent reports of this in Wirksworth and Earl Sterndale.
